GENERAL INFORMATION

AQM Pellets can be applied with the AQUA-AID PROportioner system or similar applicator during hand watering and/or syringing. Apply throughout the year with no phytotoxicity to all types of turf grasses, annuals, and perennials.

One **AQM** Pellet will cover 1 to 2 average size greens, up to 12,000 ft² (1,114 m²). Apply **AQM** Pellets as needed.

AQM Pellets will dissolve within one hour at water pressures of 90 to 120 psi (620 to 827 kPa). The rate at which an individual **AQM** Pellet dissolves is determined by water quality, temperature, pressure and flow rates. **The flow of water through the PROportioner should follow the molded arrow.** Please note some applicators have the flow opposite the molded arrow.

DIRECTIONS FOR USE

Greens, Tees, Fairways, Lawns and Sports Turf

Insert one **AQM** Pellet, with or without container, into the PROportioner jar and use when hand watering and/or syringing. Apply once a week throughout the growing season. Soak hard-to-wet areas, quickly drying mounds, newly sodded areas and highly compacted areas.

Sodding

Insert one **AQM** Pellet, with or without container, into the PROportioner jar and use when hand watering. Apply weekly on newly laid sod for increased root establishment.
